## Meeting Called to Order at 6:01pm

## Presentation (50 Min)

Heidi Travers of RI DEM and Chris Sullivan of CT DEEP, presented, then answered questions on the Pawcatuck Nutrient Study. The project website, which has an interactive story map, is: <a href="https://www.ct.gov/deep/pawcatucknutrientstudy">www.ct.gov/deep/pawcatucknutrientstudy</a>

- Resources mentioned: RI DEM completed a Total Maximum Daily Load (TMDL) Plan, 2010; Scientific Investigation Report, 2019-2020; RI TMDL for the Pawcatuck Estuary; BiState Pawcatuck Estuary Report.
- 2. Primary sources of nutrients are the waste water treatment facility and agriculture. Pawcatuck River is mostly affected after a rain event / wet weather
- 3. The watershed is researched for nutrient loading since it is a large watershed emptying in a small area, the estuarine Pawcatuck and Little Narragansett Bay. DEM chose the locations for the data to be collected and DEEP installed them. Many are monitoring sub-basins, such as Beaver River and Wood River.
- 4. In the future, RI DEM and CT DEEP hope for the Stewardship Council's help in communicating with the public and advocating for policies to decrease the nutrient load. Examples: pet waste ordinances, best practices in agriculture. Strategy: community liaisons are effective. Timeline: These state agencies will follow up once they have data.

<u>Financial Report: July 23 – August 20, 2019</u> 1. Year to Date:

- a. From January 2019 to August 20, 2019 we have expended \$25,834 of the \$166,000 Study Fund 2016 allocation, with \$8,337 remaining.
- b. Kassi (12/2018-present and 3 weeks of Denise & Kassi working together) has worked a total of 709 hours, totaling \$24,240.

  - c. Approved spending \$1,250. to reimburse WPWA for Shed Light Creative for updating videos to reflect the designation has been achieved and for speaking equipment, video and photography at the Wild and Scenic River Celebration on 4/08/19.

- 2. Bylaws Committee, Jon Ericson as Committee Chair, Presented Bylaws to the Council and sought approval.
  - a. Key sections were visited and explained
  - b. One section was altered during the meeting as to clarify there is one vote per group and that alternative representatives vote when representatives are not present.
  - c. Motion to Accept the Bylaws: Harvey; 2<sup>nd</sup>: Pete A. The motion passed with 12 votes in favor and 0 against. Members absent in voting: Narragansett Indian Tribe, North Kingstown, Sterling, Voluntown, RI Department of Environmental Management and Save the Bay.

# Kayak Trail/Boombridge Rd Repairs/Stillman Ave Dam Removal

- a. This is a multiple-town, bi-state project. Westerly and Stonington Town leaders asked the Stewardship Council (SC) for endorsement and federal funds once they become available. North Stonington First Selectmen was asked by Westerly Conservation Commission to submit a letter to the SC seeking the same. North Stonington SC Town Representatives met with First Selectman Mike Urgo, and have set up quarterly meetings. At this time, the Town Representatives don't believe the SC can submit an endorsement letter. The First Selectman is waiting for guidance from the SC before submitting a request letter.
- b. The SC does not have a process by which to assess and respond to such requests. The Stewardship Projects committee is drafting criteria to prioritize projects. The Project Review / Natural Resource Stewardship committee is drafting a letter for all towns to begin building a relationship with town staff and to solicit projects lists.
- c. The SC will be intentional in this process, since it may be positive press and precedence but it might not. Stewardship Projects committee will work on next steps, such as an acknowledgement letter. Town Representatives from the three towns, plus committee members will be involved.
- d. In general, the proposal fits the Stewardship Plan in that it restores river to free flowing, supports new access sites, consider boat access as part of road projects. The proposal may not fit the Stewardship Plan if access sites are created at locations that are not appropriate locations, if use does not support native fish, nor balance multiple uses.
- e. This matter will be further discussed in the Stewardship Projects committee and likely the September Stewardship Council meeting.

# Action Items (10 Min)

- 1. Go to Town Hall, introduce yourself to the Town Planner. Deliver the Introduction to Town letter.
  - a. This letter will be redrafted then sent to all members.
  - b. Town Representatives will revise the letter to be town specific. Inserting their town name where it says "Town," and describing the location of the WSRs and tributaries.
  - c. A goal for next Council meeting will be to discuss strategies for building relationships with, and communicating with town officials and staff.
