Committee Reports

- 1. Bylaws Entertain a motion to adopt Bylaw Revisions; MoU Update
 - a. Antonia has concerns of the wording of the insurance coverage. WPWA is covered by the policy, not W&S. With a bit explanation, her concerns were resolved. There is general interest in getting a copy of the insurance policy from WPWA. Need to explore the extent of our coverage. NPS funds can be used to carry additional insurance.
 - b. Motion to adopt by-laws change by Chris, second by Dennis. Motion approved. Madeline abstains.
 - c. Jon reviews draft MOU between WPWA and Wild and Scenic. Kassi provided a template for format. Jamie asks if it is wise to include specific projects and amounts. MOU should be timeless. Eric concurs. Projects and costs will already be documented in the annual workplan and budget request to NPS. Jon asked Council members to comment on the draft MoU by Dec 01 at which time the Bylaws Committee will revise again for further review. Jon will send out a Word copy of the draft MoU for members.
